On September 17, 2020, the Canadian Securities Administrators published amendments that, effective June 1, 2022, will prohibit the payment of trailing commissions to order execution only (referred to as *OEO*) dealers, which includes discount brokers and other dealers that do not make a suitability determination, in connection with an investor's purchase and ongoing ownership of classes of units that pay a trailing commission to dealers (referred to as the *OEO Trailer Ban*).

As a result, effective June 1, 2022, Class A units of the Fund are no longer available to investors who hold these units in an account with a discount broker. To ensure compliance with the new rule, starting on or about March 25, 2022, Class A units of the Fund held in an account with a discount broker were converted into a non-trailer paying class of the Fund offering a lower management fee.













On September 17, 2020, the Canadian Securities Administrators published amendments that, effective June 1, 2022, will prohibit the payment of trailing commissions to order execution only (referred to as *OEO*) dealers, which includes discount brokers and other dealers that do not make a suitability determination, in connection with an investor's purchase and ongoing ownership of classes of units that pay a trailing commission to dealers (referred to as the *OEO Trailer Ban*).

As a result, effective June 1, 2022, Class A units of the Fund are no longer available to investors who hold these units in an account with a discount broker. To ensure compliance with the new rule, starting on or about March 25, 2022, Class A units of the Fund held in an account with a discount broker were converted into a non-trailer paying class of the Fund offering a lower management fee.

On March 18, 2022, the Canadian Securities Administrators announced temporary exemptions to the OEO Trailer Ban, such that during the period from June 1, 2022 to November 30, 2023, OEO dealers and fund organizations are exempted from the OEO Trailer Ban for investors who transfer Class A units of the Fund to an OEO dealer account on or after June 1, 2022, provided that the dealer implements a rebate equal to the amount of the trailing commission paid by the Manager. 
