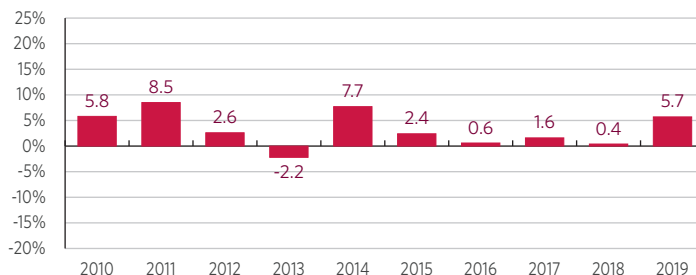

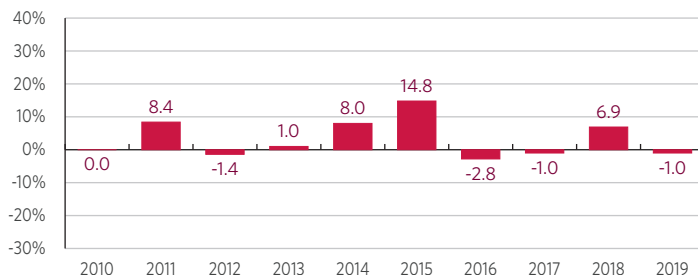

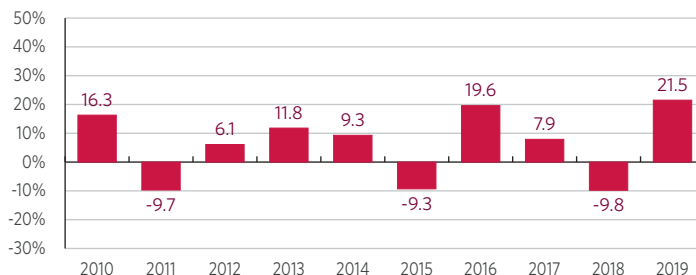

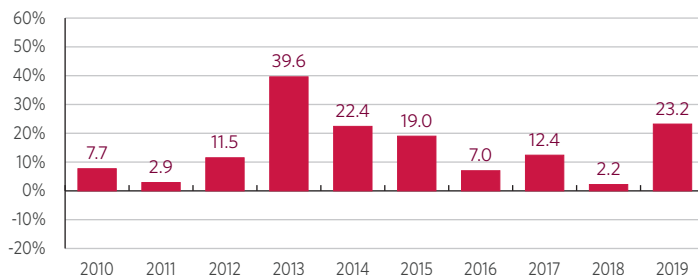

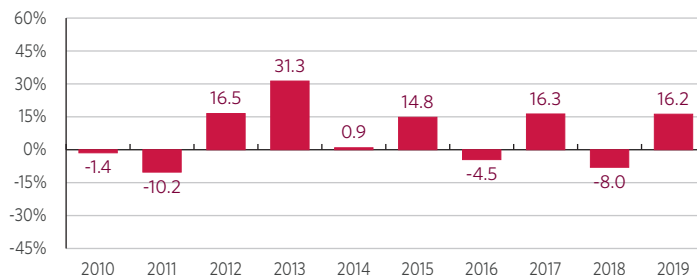

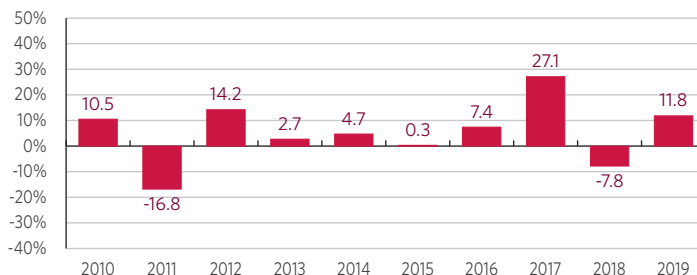

How risky is it?

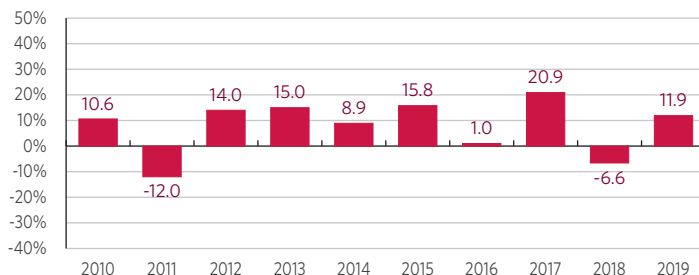
