### What does the fund invest in?

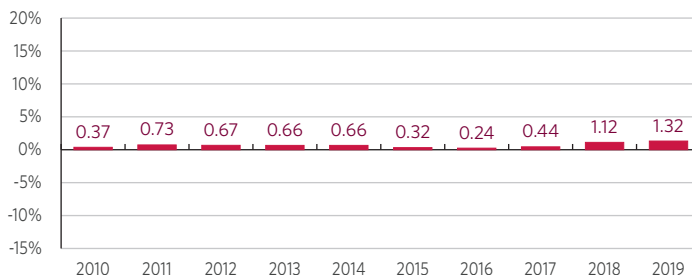

### Automatic conversion program

### More about the trailing commission

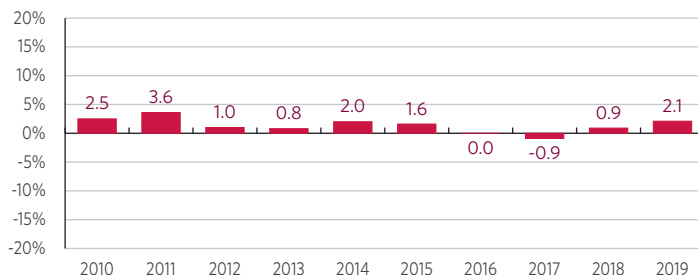

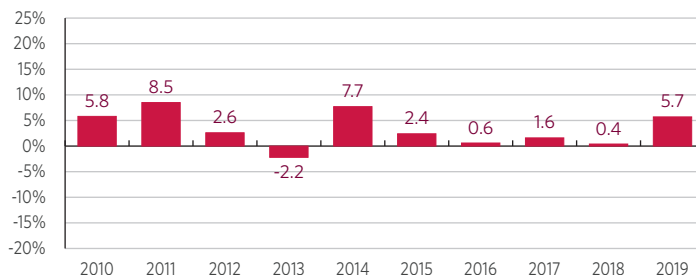

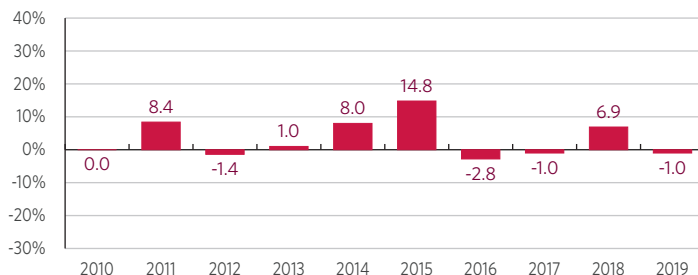

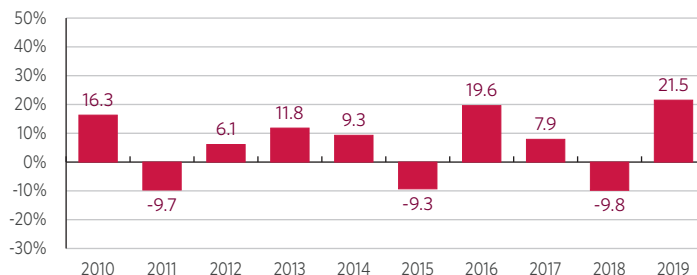

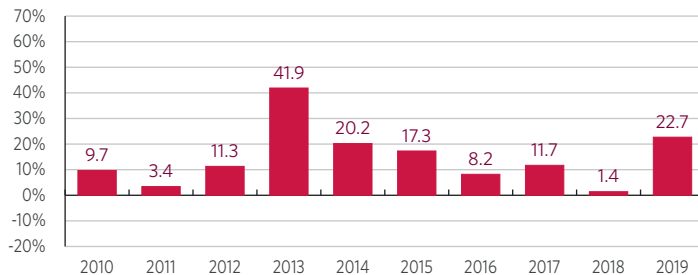

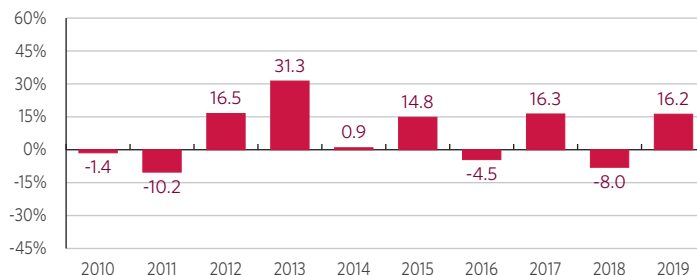

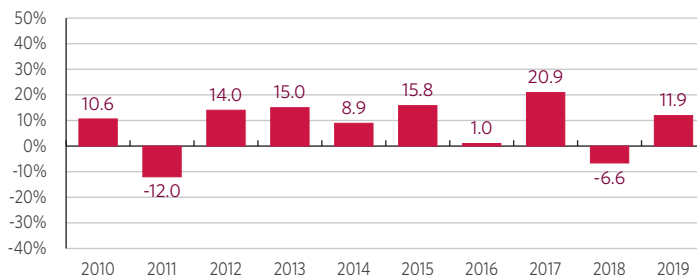
